- 120 <u>Local Police Report</u> The Clerk had sent a list of meeting dates to the local Police team with an open invitation to attend whenever possible.

- b) <u>Finance Report/Bank Reconciliation/Bank Statements</u> Members received and approved the latest finance report to 31/12/2023. Bank Reconciliation at 31 December 2023 was presented to council along with the respective bank statements and duly signed by the Chair of the meeting.
- c) Parish and Town Council Precept and Confirmation of 2024/25 Council Tax Base - Members were in receipt of the budget sheet agreed prior to the Parish Council meeting. It was proposed a precept of £46,950 for the period 2024/25 which would mean that the band D billing amount attributable to the Parish Council will be £13.25, which is no change on 2023/24.
- 125 <u>Recommendations by the Parish Council to the East Riding of Yorkshire Council on</u> <u>Planning Applications 11th January 2024</u> - None received.

Planning Decisions 11th January 2024

- Erection of single storey extension to side and rear, porch to front, fence and gate (2 metres in height) to side and rear, following demolition of existing extension to side 64 Saffrondale, Anlaby GRANTED
- 126 Environmental
 - a) <u>Request for 3 Salt Bins (Tranby Park new housing estate off Beverley Road)</u> -E.R.Y.C. had advised the residents that this estate does not meet their minimum criteria for provision of salt bins and to contact the Parish Council about the possibility of funding them. Permission would need to be sought from the developer as this site is un-adopted. Clerk to contact resident for additional information to enable further discussion.
 - b) <u>Flooding</u> Cllr. Johnson reported a large amount of standing water on the bridle way off Beverley Road.
- 127 Administration and Communication
 - a) <u>Parish Council Vacancies</u> Currently three vacancies exist on the Parish Council. The most recent vacancy due to the resignation of Cllr. Dooley which has been reported to E.R.Y.C. and is currently advertised.
 - b) <u>Social Media</u> The Clerk gave Cllr. Readshaw a draft Social Media and Electronic Communication Policy to consider. Clerk updated members on a recent discussion with the Clerk from Willerby Parish Council about her experience with social media.

 - a) <u>Update on Adoption of Aspect of Anlaby, Lowfield Road</u> E.R.Y.C. Project Manager Grounds and Forestry confirmed that E.R.Y.C. has adopted the open space areas and are now maintaining them. The Project Manager is working alongside the Aspect Neighbourhood Watch Team to resolve some issues including some persistent, intentional damage that residents are doing to part of the playing field fence and a few other ongoing issues.
