- Public Speaking Mrs. Wendy Leighton attended on behalf of St Peter's Church, Anlaby, to provide an update regarding the church clock tower. She reported that the ladder providing access to the clock mechanism has been condemned following a recent safety inspection. The Parochial Church Council considered several options but, due to financial constraints, concluded that the only viable short-term solution is to remove the ladder and disable the clock and strike mechanism. The estimated cost for ladder removal is £3,500. Replacing the ladder would cost approximately £30,000, which is currently unaffordable for the Church. The Parish Council agreed to assist by displaying notices on the parish noticeboards to inform residents of the situation.

#### 191 Environmental

- Anlaby Common Emma Hardy MP provided the following update. "I have spoken to the Living With Water team regarding the Common West Drain. They confirmed that the culvert is the responsibility of the property owners under whose land it passes. They are aware of the work on the Common drainage channels and plan to inspect the culvert in due course as part of a wider programme of works as part of their Blue Green Plan. Natural England have informed me that they do not undertake in-field surveys, however if a planning request is submitted a survey will be required. On my request, they conducted an interval review and reported the last survey of the Common took place in 2009, when no Great Crested Newts (GCN) were found. They had no historic records or other evidence of GCN presence on the Common, or the surrounding area. I was alerted to a parcel of land for sale for development adjacent to the Common on Hull Road. I have contacted Central Land Holdings (CLH) who have confirmed that it is not their land and none of the Common which they own is up for sale. The ERYC Local Plan Update was adopted on April 2nd by a meeting of Full Council and the Common area remains designated as a Key Open Area, about which the Strategy Document says 'The areas of countryside separating the individual Major Haltemprice Settlements from each other, and with Hull, are of particular importance to preventing coalescence'. I have arranged a meeting with CLH at the end of the month and will be in touch after". The Clerk was asked to request permission to share this update on the Parish Council's Facebook page and website. Additionally, request that during the upcoming meeting with Central Land Holdings, Emma Hardy MP inquire whether they would consider selling the land and, if so, at what price.
- b) <u>Anlaby Woods (Lowfield Road)</u> Members agreed to monitor the ongoing development at St Mary's Care Centre. Cllr. Slingsby will add the site to the list of potential development locations.

- Parish Council Website/Social Media and Communication Cllr. Slingsby reported that enquiries had been made regarding the transfer of the Parish Council's website to a .gov.uk domain, along with the setup of new email addresses for all members.
- b) <u>Update of Parish Council Procedures</u> The Clerk had met with ERNLLCA to review the model financial regulations. Following this review, the updated regulations were approved by the Parish Council.

The Parish Council is currently exploring options for Speed Indicator Devices (SIDs), with Hull Road being one of the proposed locations awaiting approval from East Riding of Yorkshire Council. The Clerk was asked to forward the resident's email to E.R.Y.C. for their consideration.

E.R.Y.C. grass cutting operative damaging trees</u> The Clerk reported that damage to a tree on Sykes Close had been brought to her attention by a resident, who stated it was caused by an E.R.Y.C. operative. The incident had been reported to the E.R.Y.C. Tree Officer for further investigation.
